**Ways to Give**

- 1. Cash:** Cash gifts are simple and may be made by check, automatic payment from your bank account, or online.
- 2. Stock:** Appreciated stocks may be more beneficial to give than cash. Giving stocks allows for a tax deduction for the current market value without incurring tax on the capital gain. For instructions, see the website or contact Kienan Mick, Accounting Manager (kmick@wpc-mpls.org), and then ask your broker to initiate the process.
- 3. IRA (Individual Retirement Account):** If you're over age 70 1/2, you may meet your required minimum distribution (RMD) requirement and donate from your IRA without paying income taxes on the distribution, up to an annual maximum of \$100,000. Contact your IRA administrator.
- 4. Other:** Matching gifts from your employer may be an option (contact Mary Hess for information).
